

# Veritas Technical Support – Extended Software Support Certificate



February 2023

This document (the "Certificate") is a legal agreement between the end user (the "Customer") and Veritas Technologies LLC and/or its subsidiaries ("Veritas"). This Certificate and the rights granted herein are only effective as to end users who have a valid license pursuant to a Veritas license agreement (the "License Agreement") and a valid support agreement ("Support Agreement") for either Basic Maintenance or Essential Support ("Underlying Support") for the underlying Veritas software products ("Software") for which Extended Software Support (as defined below) will be provided. Capitalized terms are defined in this Certificate, the License Agreement, the Support Agreement, the Technical Support Policy, or the Product Life Cycle Policy. This Certificate applies to the Software that is within the product family Customer has purchased, as identified on the front of the Certificate, and is in the Extended Phase of its lifecycle as detailed at <https://sort.veritas.com/eosl> ("Eligible Software").

If this Certificate applies to a consolidated order where there are multiple entitlement owners listed on the front of the Certificate, then the end user entity receiving this Certificate must provide this Certificate, including these Sustaining Software Support terms, to each of the entitlement owners listed on the front of the Certificate.

IF CUSTOMER DOES NOT AGREE TO THESE TERMS, THEN VERITAS IS UNABLE TO PROVIDE THE SUPPORT DESCRIBED HEREIN TO CUSTOMER. RECEIPT OF SUCH SUPPORT INDICATES CUSTOMER'S AGREEMENT TO THESE TERMS.

**Extended Software Support Offering:** Veritas will provide to Customer the extended software support service(s) ("ESS") during the period specified on the front of this Certificate for Eligible Software within the region in which the Eligible Software is licensed for use as indicated in the License Agreement. ESS is provided until the end date of the term purchased unless any or all of the Eligible Software otherwise reaches the Sustaining Phase during the ESS term. In such event, Veritas will honor the remainder of the ESS term purchased, but only provide support at the Sustaining Software Support level for such affected Eligible Software as detailed at <https://www.veritas.com/company/legal/license-agreements>. ESS includes the following features provided on a commercially reasonable basis:

- Continued access to technical support on a 24x7 basis (for Customers who have purchased Essential Support as the Underlying Support) or Regional Business Hours (for Customers who have purchased Basic Maintenance as the Underlying Support)
- Continued access to the Veritas technical support website
- Provision solely of known fixes, patches, workarounds, existing maintenance packs, or information from Veritas' technical knowledge base
- Provision of limited critical security vulnerability fixes at Veritas' sole discretion

## Terms and Conditions:

- **Payment:** Customer's right to receive ESS is subject to payment of fees for both the required Underlying Support and such ESS. If Customer fails to pay such fees, and the amount due remains unpaid ten (10) days following written notice to Customer of non-payment, then Veritas shall have the right to suspend or terminate the provision of ESS. Where Customer's processing of the personal data provided to Veritas under this Certificate is subject to the General Data Protection Regulation (EU) 2016/679, or other applicable laws that relate to the processing of personal data and privacy that may exist in the European Economic Area, United Kingdom, or Switzerland, Veritas shall process such personal data in accordance with the Data Processing Terms and Conditions at <https://www.veritas.com/privacy>. For ESS not performed as warranted in this provision and provided Customer has reported such non-conformance to Veritas within thirty (30) days of performance of such non-conforming ESS, Veritas will, at its discretion, either correct any nonconforming ESS or refund the relevant fees paid for the nonconforming ESS. THIS IS CUSTOMER'S EXCLUSIVE REMEDY AND VERITAS' SOLE LIABILITY ARISING IN CONNECTION WITH THE ESS WARRANTY DESCRIBED IN THIS SECTION.
